The Christian Outreach Project Rules and Regulations

The following will constitute serious violations of camp rules and regulations established for those attending the Christian Outreach Project:

1. The possession or use of alcoholic beverages or illegal drugs.
2. Possession of explosives, fireworks, or weapons
3. Unnecessary noise or disturbances
4. Tampering with fire fighting equipment or fire alarm systems
5. Destruction of facilities or personal property
6. Failure to comply with staff acting within the scope of their responsibilities
7. Youth participants may not drive person vehicles during the project (including 18 yr. olds)
8. No smoking will be allowed for the week

In respect of others, your activities should be restricted to areas in which you are assigned. Other areas will be off limits. All participants are expected to participate fully in all aspects of the program from Sunday afternoon through the close of activities on Saturday morning. Participants of COP represent the program and are the “face” of COP – as such, participants are expected to dress appropriately at all times, especially when visiting local churches for meals and worship.

Quiet Hours/Bed Times:

In the interest of guaranteeing proper sleep and rest for all participants, everyone must abide by quiet hours and bed times according to program leadership.

These rules and regulations are not meant to be all-inclusive. In all situations, we ask that good common sense be used and proper respect and consideration be given to all individuals.

Violations of project rules or regulations may result in immediate suspension from the Christian Outreach Project.

Covenant for Adult Participants

Adult participants are essential to the Christian Outreach Project. We covenant to work with youth, crew leaders, supervisors, and program staff in the improvement of group and home owner relationships. We will support program and worship participation. We realize that at times supervisors will be pulled away from the larger group activities to visit other job sites and prepare for the following work day.

Our covenant is to give as serious consideration to the human aspects of our work as to the technical. We will treat the youth and home owners as peers and affirm that we can learn as much from them as we can teach.

Finally, as adults we will seek to support other adults in carrying out the project. We are one Christian Outreach Project, carried out in many sites. By agreeing to support each other, and not be “free agents”, we covenant together to make the Christian Outreach Project the best we can make it for all.

I understand that I am expected to be present for the entire C.O.P project week unless special arrangements have been made in advance. I understand that if I am in residence, I will be expected to provide night supervision, and be particularly responsible for those youth that I have listed on the front of this form. By signing this form, I affirm the covenant for adults and agree to live by, and promote the rules, regulations, and program of the Christian Outreach Project. Furthermore, I also agree that by participating in C.O.P. that my image may be used in promotional materials (print, video, web, etc.) related to the Christian Outreach Project.
